North Central Washington Libraries 2023 Board Retreat May 11, 2023 8:00 am-5:00 pm NCW Community Foundation, 9 S Wenatchee Ave, Wenatchee, WA

I. Meeting Commenced

Attendees arrived between 8 – 8:15 a.m., and the retreat commenced at 8:15 a.m.

II. Attendees

Those absent included Alicia Gomori, Associate Director of Community Libraries.

IV. Welcome / Agenda / Norms

Barbara began with a welcome to attendees . Summer, as facilitator, reviewed the meeting structure by defining the following:

Parking Lot - important issues to be addressed outside of the retreat.

<u>Garden Bed</u> – issues/suggestions that fall outside the board's role but should receive consideration from ELT.

<u>Intellectual Freedom</u> – recognizing that we represent people from diverse communities and therefore need to model the library's stance through listening and respectful sharing of opinions; speak from personal experience; take notes in order capture ideas.

Summer then reviewed the norms for the day to assist with respectful communication, to which each person verbally agreed.

Each person shared an experience to "Describe a time that you have been a champion for a person or project you were passionate about."

VII. Strategic Plan Overview

Barbara shared with the board her vision for the library two big goals:

- a successful levy lid lift within the next 5 years, and
- to double the way people engage with libraries in the next 10 years.

She reviewed current major initiatives (i.e. Reimagining Spaces) and the challenges facing the organization: budget, staffing, and use changes, and shared a budget comparison of NCWL to other similar library districts. Kim expounded on the some of these topics, touching on the branch leaderhip expansion, development of volunteer standards and circulation manuals.

VIII. Board Member Vision

Trustees were reminded of their vision adopted during the last Strategic Plan and were given an opportunity to brainstorm individually their vision for NCWL. After sharing and discussing their visions with the group, revised visions based on this exercise.

X. Levy Lid Lift Presentation

Jill Jean, Director of Kitsap Regional Library, presented on how she accomplished a successful levy lid lift for her library district in 2017.

XI. Trustee Action Items

Discussion about the role of trustees and how they can best advocate for NCWL in the communities it serves, and act as good financial stewards by staying informed and helping to maintain the long-term financial health of the district.

XII. Budget Outlook

Mike presented a detailed 5-year financial forecast, showing how rising costs will cause expenses to exceed revenues in the coming years. He also gave projections of how an increase in property taxes would help stem the budgetary shortfall. The board and staff discussed the need to prepare for a levy lid lift in order to increase revenue to maintain current library services.

Erin McCool and Julie Norton gave a thorough and informative presentation on the Open Public Meetings Act and the legalities thereof.
